#### INTRODUCTION:

The Manipur Fire Service was established on 11th April 1957 as part of the Police Department. However, on 1st May 1991, it was restructured into an independent Directorate, headed by a professional Director. Since its inception, the Fire Service has played a crucial role in protecting lives, property, and the environment across the state of Manipur.

#### ORGANISATIONAL SETUP:

The Directorate operates 19 Fire Stations/Sub-Stations out of the 29 authorized Fire Sub-Stations, strategically located across 16 District Headquarters and Sub-Divisional Headquarters. The Fire Station at Imphal Headquarters serves as the central hub of operations, delivering critical fire and emergency services throughout the region.

While firefighting remains our primary responsibility, we have expanded our role to encompass a wide range of emergency services, including:

- Building collapses
- · Road traffic accidents
- Drownings
- Rescue operations for both humans and animals.

In addition to responding to emergencies, the Manipur Fire Service is deeply committed to fire prevention. We conduct public awareness campaigns, provide fire safety training, and ensure the implementation of fire protection measures across various types of buildings and occupancies.

The Manipur Fire Service is steadfast in its mission to serve the people of Manipur, offering life-saving services, preventing fire hazards, and promoting public safety through comprehensive fire and emergency management efforts.

#### SPECIAL SERVICES:

Beyond basic firefighting duties, the Fire & Emergency Services undertake standby duties at several significant events, including exhibitions, major fairs, VVIP visits, and security-related functions. Our personnel also provide support for national and state-level events to ensure safety and security.

Every year, the organization observes **Fire Service Week** from 14th to 20th April, under the motto: **"WE SERVE TO SAVE."** This week is dedicated to raising awareness about fire safety and honoring the sacrifices made by firefighters in protecting the community.
